6. Resolution/Ordinance

a. Resolution No. 2021-10

Manager Caccavo reported that this was an annual item that allows for the District to participate in the SD County Fire Mitigation Fee program. This program assists with funding equipment and facilities in relation to new development in the jurisdiction. Chief Cox further reported that changes to the program will now allow the Fire Board to approve the 5-year spending plan and percentages for requests, for capital related to new growth, from the Fire Chief instead of approval from the County Fire Mitigation Committee.

7. Oral Report

a. Fire Chief – Cox

COVID-19 - Update

Chief Cox reported that the District has had no new known cases. EMS Coordinator Ruiz reported that the District had a total number of 43 assessments; of the 43 assessments 6 results returned positive. For calendar year 2021 the District has had 4 assessments, all with negative results. Chief Cox stated that the District is continuing to operate in the County vaccination Points of Delivery (POD's), currently 4 staff members are participating. The District will be reimbursed fully using the OES administrative rates for their efforts. District Activities

Chief Cox reported that Chief Wellhouser of RSF Patrol has met with modular designers and will be getting quotes shortly.

The memorial signs for Captains Mosby and Mertz have been received and placed at Stations #3 & #5 respectfully.

Chief Cox stated that staff is working on Covid related expenses for the American Rescue Plan. Special Districts, previously excluded from relief funds, may have opportunity to request reimbursement for Covid related expenses.

Chief Cox reported that the Pierce Type III rig should be arriving within the week.

Chief Cox reported that the County is going to be clearing 20' along the highways which is an increase over the previous roadway clearance of 10'; this includes areas along the Del Dios Highway.

Chief Cox stated that staff has started working on the Preliminary Budget.

Chief Cox reported that insurance issues are starting to rise with residents being denied insurance coverage. Fire Prevention Specialist Closs has found a link that will advise companies that will write policies on previously denied residents using their zip code.

Chief Cox reported that all of the Administrative staff, except one, have been vaccinated; 65% of Suppression staff have been vaccinated.

Chief Cox reported that, of the \$668,000 the Federal government owes in reimbursement from the last fire season, \$239,000 has been queued up for payment. The State still owes additional money also. Overtime budget will be over, however Staff is working diligently to monitor and track those expenses.

b. Operations - Deputy Chief McQuead

Chief McQuead reported that work on the vaccination with fixed PODs has continued. Long term care facilities and agriculture sites have been included.

c. Volunteer – Volunteer Recruitment & Retention Coordinator Chief Twohy

Chief Twohy reported that the reserve program has been restarted. The group has contributed 456 hours in service to the community since the last meeting.

d. Training - Battalion Chief Sherwood

Chief Sherwood reported that all the engine companies have completed all the required and needed training. He added that EMS certifications are back face to face for hands on training following Covid guidelines. Firefighter Fernandez was released from probation; previously was a reserve firefighter. Saturday, March 20th will be doing firefighter new hire testing for three reserves.

e. Fire Prevention - Fire Marshal Donner

Fire Marshal Donner reported that engine companies have all been trained on the inspection program which will allow access to plans and contact information. The engine companies will also advise Fire Prevention on new business in the District. Assembly bill 38, going into effect July 1, requires buyers to receive documentation that certain properties are compliant with wildfire protection measures. Governor Newsom proposed \$30 million in a retro fit program, which local districts can apply to administer the program. As of July 1, new code cycle for new construction will be rolled out. Solar plans are not being reviewed by the County as per the Districts requirements. Training has been completed by Prevention staff on insurance cancellations. Plan checks are picking up with 15 in the queue.

f. Manager, Finance & Administration

Manager Caccavo reported that for Finance staff is working on Covid relief funds; Brush rig should be delivered tomorrow. For HR, recruitments currently running are for the Firefighter, B/C and Office Support Coordinator. Sarah Montagne has moved over to the Admin department as Accounting Technician and is doing fantastic. For the Board Clerk, all 700 forms received and the District is in compliance.

g. Board of Directors

- i. North County Dispatch JPA Director Ashcraft reported that for year 2020 the District had medical aids totaling 1153 calls; residential alarms 475; residential fires 16; traffic collisions 141; and vehicle fires 11. JPA reports calls are down 3.37%, however Rancho Santa Fe Fire Protection District calls were up 5.62%. Current assessment is \$197,135; next year effective July 1 will be \$205,652.
- ii. County Service Area 17 Director Stine reported no news to report.
- iii. Comments Director Stine: none; Director Tanner: thanked Chief Cox for assisting with Covid shot; Director Malin: older daughter and wife had some serious side effects on the second shot, other daughter has been administering Covid shots as a new RN.



April - July 2021 South Ops Highlights

- Rainfall will be near to a little below normal in April and then below normal May through July.
- Temperatures will be a little below normal each month through July.
- The marine layer will be deeper than normal across the coastal areas May and June.
- Monsoonal showers and thunderstorms will be below normal in July.



Weather Discussion




Fig 3: Snow pack as of Mar 31st, 2021

Below normal temperatures were observed most of March as a series of upper level Pacific troughs moved into the West Coast from the Gulf of Alaska (Fig 1). A series of cold, upper level low pressure systems moved through California and brought periods of showers and isolated thunderstorms to the region during the first half of the month. A slow-moving storm that developed on March 9th brought a few days of heavier precipitation totals to many areas of the state. Several feet of new snow fell over the High Sierra and snow levels that hovered around 4,000 feet helped to generate over a foot of new snow across the higher mountain elevations of Southern California. The upper level low pressure systems that arrived late in the month were not as cold and did not import substantial amounts of moisture into the region. As a result. precipitation totals dwindled and ended up below normal for most of the region in March (Fig 2). The Sierra snowpack also decreased slightly by the end of the month and is now between 40% and 70% of normal (Fig 3). Winds were predominately onshore (westerly) most of the month as strong, gusty winds surfaced across the mountain ridges and desert passes with each trough passage. However, the ridge of high pressure over the eastern Pacific Ocean gradually amplified and shifted closer to the West Coast during the last week of March. This forced a few fast-moving troughs to drop from the Pacific Northwest into the Great Basin and Desert Southwest causing a couple of weak to moderate offshore wind events across Southern California.

Fuels Discussion




Fig 6: LA County Live Fuel Moisture March 15th




Fig 4: Southern Mountains 1000 hr Dead fuel moisture March 31st




Fig 5: Central Sierra 100 hr Dead fuel moisture March 31st






Fig 7: Drought Monitor March 30th, 2021

Both the 1000-hr and 100-hr dead fuel moisture values increased significantly in March due to the persistent trough pattern and cool, more humid conditions. Across all predictive service areas, these dead fuel moisture values are now close to normal (Fig 4 and Fig 5). Greenup was in full progress during March. Even though live fuel moistures started to peak and level off, the values are still well below normal for this time of the year (Fig 6). With the persistence of below normal precipitation, drought conditions have accelerated within the coastal areas of both central and southern California with some areas. elevated into moderate drought status (Fig 7). Drought conditions have changed little across the interior portions of the area and still are mainly in the moderate to severe categories. Extreme to exceptional drought remain over the deserts bordering Nevada and Arizona.

SOUTH OPS OUTLOOK





Fig 9: Forecast Temperature Anomalies for April through July, March 29th, 2021

Expect little change in the weather pattern in April as sea surface temperatures in the Gulf of Alaska and along the West Coast remain below normal (Fig 8). Additionally, an upper level trough pattern is expected to be the dominant weather feature over California during April. This will effectively keep temperatures below normal and allow scattered showers and isolated thunderstorms to move across the region from time to time. Even though sea surface temperatures have shown minimal warming over portions of the Equatorial Pacific (Fig 8), forecast models continue to suggest little change in sea surface temperatures across the Pacific Ocean through June into July (Fig 9). This will keep the marine layer deeper than normal and daytime temperatures will likely remain on the cool side of normal during the spring months and heading into summer. There will likely be little in the way of rainfall across most of the region from May through July as the storm track moves northward into the Pacific Northwest and upper level troughs become weaker across California. However, these troughs still have the potential to introduce a few showers and thunderstorms to the Sierra. The precipitation from any shower and thunderstorm activity is expected to be below normal in July as models continue to show troughing over the northern tier of the United States that may shunt the influence of the Southwest Monsoon south of the Four Corners region and effectively cut off the feed of tropical moisture into southern and central California. The large fire threat will likely become above normal in July due to the absence of significant moisture from the monsoon, especially given the fact that precipitation has trended well below normal for the entire water year and fuels will be abnormally dry and receptive to new starts. Any lightning will be problematic in July due to the anticipated drier nature of storms especially if a lightning outbreak coincides with an extreme heat event.



Re: COVID-19 Impacts on California's Fire Districts

Dear Governor Newsom, Pro Tem Atkins, and Speaker Rendon:

California's fire protection districts continue to serve tirelessly as vital frontline responders during the ongoing COVID-19 pandemic; however, access to relief funding for our agencies has been limited, causing an undue burden on fire protection and emergency medical services. This has been especially true for agencies that are special districts, whose work alongside other special district partners to gain direct access to federal stimulus funding has been disappointingly unsuccessful to date. With Congress passing the American Rescue Plan Act of 2021, we now look to your Administration and Legislature to acknowledge the crucial role that first responders play in COVID-19 response and recovery, and support that essential work being provided throughout the State by ensuring that our agencies receive access to relief funding to offset the impact of response and recovery efforts.

The impact of the COVID-19 pandemic on fire protection districts has been profound, both fiscally and operationally. More than one month before a State of Emergency Declaration was made in California, fire protection districts and EMS providers began changing operational response protocols as the CDC confirmed the first COVID-19 case in the State on January 26, 2020. These changes altered every aspect of how service is provided, including PPE protocols, patient care protocols, supply utilization and stocking, health and safety procedures, staffing plans, and exposure reporting, among a multitude of others. Each time new guidance and recommendations were issued by public health officials, operational changes were necessary. Implementing these changes came at a significant cost. Faster PPE and supply burn rates resulted in increased PPE and supply costs; increases that were exacerbated by supply chain disruptions. Workers' compensation claims and overtime costs skyrocketed as maintaining sufficient staffing in a high-exposure environment became the norm. Labor costs were further increased to provide support to public health officials in their testing and vaccination efforts throughout the State.

While response and recovery costs were mounting, vital revenue sources for many districts were reduced, with fee-for-service EMS transport revenues plummeting for a good portion of 2020. The cumulative result of increased costs and reduced revenues has crippled fire protection district budgets throughout the State. For the Sacramento Metropolitan Fire District (Metro Fire), this impact has been a net loss of nearly \$5.5 million since March of 2020, with only an estimated \$1 million expected to be reimbursed through current available relief sources.

The collective mission of fire districts throughout the State is to ensure the safety of our communities. The losses experienced statewide as a result of the COVID-19 pandemic have compromised the capacity to fulfill this mission, resulting in reduced service, un-funded programs, and deferred capital projects, among others. While other industries and public service agencies have access to lifeline funding, this funding has not been made available to the very agencies that provide lifeline support to the community. In order to support the Master Agenda

essential work that fire districts provide in this State, we urge you to dedicate a portion of the State's allocation of the American Rescue Plan Act funds to fire districts in desperate need of relief funding.

RECOMMENDATION:

- 1. Declare listed property as surplus and sell at the determined fair market value of \$42,013.93 to the Valley Center Fire Protection District (VCFPD) with consideration for the restoration of property to rough grade and removal of any debris where the structures were located.
- 2. Authorize the Fire Chief to enter into discussions with VCFPD to finalize the sales agreement. Pending finalization of agreement, authorize the Board President to execute and deliver this agreement.

BACKGROUND:

The District owns two single wide manufactured homes (buildings) and a steel canopy that were used as a temporary fire station during the construction of Fire Station 5. Now that Fire Station 5 is completed, the temporary buildings are no longer needed.

All three buildings are located in a Limited Building Zone (LBZ) easement and are required to be removed within one year of completion of Fire Station 5. After one year, if the buildings remain in this LBZ, the County of San Diego or its agents have the authority to remove such buildings and invoice all costs to the District.

The VCFPD is in need of a temporary facility for their new Fire Station #3. The sale to VCFPD, another public fire protection district, is in the interests of public safety and improves fire protection to area residents and the region as a whole. The VCFPD will be responsible for all costs to remove such buildings and return the building pads to a rough grade condition. Staff feels this is a mutually beneficial agreement for both agencies.

Legal counsel has provided the attached sales agreement. Pending no major changes to the agreement, staff makes the recommendation as outlined above.



Any other adjustments, taxes, fees, proration's, and any other charges shall be the responsibility of the Buyer. Buyer shall bear all costs of moving/removing the Property from Seller's facility.
- 3. <u>Payment of Purchase Price</u>. The Purchase Price for the Property shall be payable by Buyer to Seller upon delivery of the signed transfer documents for items 1.a. and 1.b. and prior to moving/removing the Property by Buyer.
- 4. Free and Clear. Seller warrants that Property is unencumbered and is free of any liens or debt.
- 5. <u>AS-IS and Release</u>. Buyer hereby expressly acknowledges and agrees that (i) Buyer has been given the opportunity to thoroughly inspect and examine the Property to the extent deemed necessary by Buyer in order to enable Buyer to evaluate the purchase of the Property, (ii) Buyer is purchasing the Property on an "as is" "where is" and "with all faults" basis, without representations, warranties or covenants express or implied of any kind or nature, (iii) Buyer is relying solely upon its own inspections, investigations and analyses regarding the physical condition, title and quality of the Property, and (vi) Buyer acknowledges that they have had the opportunity to complete all physical and financial examinations relating to the acquisition of the Property.

Effective upon the Closing, Buyer and anyone claiming by, through or under Buyer hereby fully and irrevocably releases Seller and its respective officers, Board of Directors, employees, agents, attorneys, successors and assigns from any and all claims that such parties may now have or hereafter acquire against such persons and entities for any cost, loss, liability, damage, expense, demand, action or cause of action arising from or related to any condition of the Property including any construction defects, errors or omissions, compliance with law matters, or any other condition or circumstance affecting the Property, its use or operation, or any portion thereof and all losses, costs, claims, liabilities, expenses and demands relating to the Property. This release includes claims of which Buyer is presently unaware or which Buyer does not presently suspect to exist in its favor which, if known by Buyer, would materially affect Buyer's release of Seller.

Therefore, Buyer acknowledges that it has been informed of, and they are familiar with, Section 1542 of the Civil Code of the State of California, which provides as follows:

A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.

Buyer hereby waives and relinquishes all rights and benefits it has or may have under Section 1542 of the Civil Code of the State of California, to the full extent it lawfully may waive all such rights and benefits pertaining to the subject matters of this waiver and release.

Each and every provision of this Section 4 shall survive the Closing. Buyer acknowledges that but for Buyer's agreement to each and every provision of this Section 5, Seller would not have entered into this Agreement.

6. <u>Closing</u>. The purchase of the Property by Buyer from Seller shall take place at such other place as the Parties agree on or before ______ ("Closing"). At Closing, Seller shall tender to Buyer possession, a Bill of Sale, transfer document regarding items 1.a. and 1.b. and Buyer will tender to Seller the Purchase Price.

- 7. <u>Removal of Property.</u> Buyer is responsible to remove at its cost, all the Property and all appurtenances from Seller's premise within ninety (90) days of execution of agreement; but no later than August 30, 2021. Where required by law, removal shall be done by a licensed and insured contractor. Said contractor shall be fully insured with:
 - a. Commercial General Liability Insurance with commercial general liability insurance of equivalent form with a combined single limit of not less than \$1,000,000 per occurrence. If such insurance contains a general aggregate limit, it shall apply separately to this Agreement or be no less than two times the occurrence limit.
 - b. Worker's Compensation Insurance within statuary limits.
 - c. Business Automobile Liability Insurance or equivalent form with a combined single limit of not less than \$1,000,000 per occurrence. Such insurance shall include coverage for hired vehicles. Non-owned automobiles shall be covered by the general liability policy.
- 8. <u>Seller's Policies</u>. Buyer and Buyer's contractor agrees to comply with all Seller's rules, policies and procedures while conducting any work on Seller's premises.
- 9. <u>Condition of Premises</u>. As consideration for the sale of the Property to Buyer by Seller, Buyer agrees to and shall remove all debris, remove or crush and backfill existing septic tank, unhook and remove all utilities, remove all debris from the premises and return the site back to a rough grade condition. Existing asphalt is to remain.
- 10. <u>Risk of Loss</u>. Upon Closing, title to the Property shall transfer to Buyer and Buyer assumes all risk of loss of the Property thereafter. It shall be the Buyers responsibility to properly insure Property after the execution of this Agreement.
- 11. <u>Hold Harmless</u>. Buyer agrees to indemnify, defend and hold harmless Seller from any loss or damage or liability, including the risk of loss or damage, resulting from any act, failure to act, or omission (i) on the part of Buyer's contractor in carrying out the provisions this Agreement and (ii) the ownership and use of the Property after the Closing, excepting the grossly negligent Seller, its employee acting within the scope of his/her official duties. Buyer agrees, without expense to the Seller, to save Seller harmless from and defend the Seller against all losses, all liabilities, expenses and other detriments of every nature and description to which the Seller may be subjected as a result of claim, demand, action or cause of action which may be made or had against the Seller as a result of any negligent acts or omissions on the part of the Buyer, Buyer's Agent or Buyer's Contractor.

12. Miscellaneous.

- 12.1. <u>Attorneys' Fees</u>. If any action is commenced to enforce or interpret any provision of this Agreement, the prevailing party shall be entitled to recover from the other party actual attorneys' fees and costs incurred in connection with such action, in addition to all other proper relief.
- 12.2. <u>Controlling Law</u>. This Agreement shall be governed by and construed under the laws of the State of California, without regard to its principles of conflict of laws.
- 12.3. <u>Successors and Assigns</u>. This Agreement shall inure to the benefit of and be binding upon the parties hereto and their respective heirs, executors, administrators, successors, and assigns.
- 12.4. <u>Necessary Acts.</u> The parties hereto shall sign or cause to be signed all documents and shall perform or cause to be performed all acts necessary to consummate the transactions contemplated hereunder.

- 12.5. <u>Modification</u>. This Agreement may be modified or rescinded only by a writing signed by all parties to this Agreement or by their duly authorized agents.
- 12.6 <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each of which shall be an original and all of which together shall constitute but one and the same document.
- 12.7 <u>Entire Agreement</u>. This Agreement contains the entire Agreement between the parties relating to the transaction contemplated hereby and, except as otherwise expressly provided herein, all prior and contemporaneous agreements, understandings, representations and statements, oral and written, are merged herein.
- 12.8 <u>No Implied Waiver</u>. The waiver by one party of the performance of any covenant, condition, or promise shall not invalidate this Agreement nor shall it be considered a waiver by that party of any other covenant, condition or promise. The waiver by any part of the time for performing any act shall not constitute any waiver of the time for performing any other act or an identical act required to be performed at a later time. The exercise of any remedy provided for in this Agreement shall not be a waiver of any consistent remedy provided by law, and the provision in this Agreement of or any remedy shall not exclude other consistent remedies unless they are expressly excluded.
- 12.9 <u>Assignment</u>. Neither party may assign any of its rights, duties, or obligations under this Agreement.
 - 12.10. <u>Time</u>. Time is of the essence as to acts under this Agreement.
- 12.11. <u>Interpretation</u>. The terms of this Agreement have been negotiated by the parties hereto and the language used in this Agreement shall be deemed to be the language chosen by the parties hereto to express their mutual intent. This Agreement shall be construed without regard to any presumption or rule requiring construction against the party causing such instrument or any portion thereof to be drafted, or in favor of the party receiving a particular benefit under the Agreement. No rule of strict construction will be applied against any person.
- 12.12 <u>Authority</u>. Each person signing this Agreement represents and warrants that he or she is duly authorized and has legal capacity to execute and deliver this Agreement.
