5. Oral Report

a. Fire Chief:

Fire Chief McQuead reported an update on the Pinnacle Project. Mosby being added to Capitol Park Memorial 10/12. Provided positive feedback on AFSS conference last week. Looking into AFG grant for SCBA's. April 24th we will be having Admin Professionals Appreciation Lunch. Made an offer to a candidate for Accounting Specialist I and published IT Specialist position opening.

b. Operations:

Deputy Chief Slattery reported 17 applications for FF/PM, 13 testing. NZ Captains test was April 10th; 2 candidates passed. NZ BC Exam is May 15th; 2 applicants. Escondido on-boarding April 29th. Hosted FOTS class at Station 2 on 4/13; 29 students. Type VI should be on the floor at the end of May. Extended Wildland Attack Drill next Thursday. 417 total calls for March. M266 has been removed and M232 is now 24 hours. CSA-17 advisory committee meeting May 7th @ 4p.

c. Training:

Deputy Chief Slattery reported that we have concluded the 2024 NZ Engineer Exam, hosted all participant agencies at RSF2. Crews did amazing job as hosts accommodating all agency needs. RSF Candidates were all successful and did well. Conducting more Command-and-Control training (Blue Card Labs) for all 3 divisions. Sets and reps with sim lab/headsets/iPads. All BC's attended the Extended Attack Preparation Drill at SMC getting ready for the fire season and the potential for complex incidents that go into extended operations. Manipulative RT-130 (Refresher Training) has been completed. Manipulative RT-130 (Refresher Training) has been completed. Participated in the "Every 15 Minutes" program at Del Norte HS through CHP with AMR and Reach Air Ambulance.

d. Fire Prevention:

Fire Marshal Donner reported 102 plan reviews last month; 488 Weed Abatement inspections; 43 Construction Inspections. Cymer/ASML wanting to expand the 17075 Thornmint Building – adding lab space and clean rooms; 30,000sf. TI; We currently have 15 projects in the queue for ASML/Cymer. Morgan Run is now called La Valle Coastal Club – has submitted the 3 residential buildings for a major interior remodel. The Inn @ RSF submitted the next phase of fire alarm plans. We have been noticing False Alarms -\$7745 billed; Since January we have run a little over 122 false alarm calls. Weed abatement annual mailer is currently being reviewed and we are getting ready to send it out. In the process of updating the fee schedule.







<u>May – August 2024 South Ops Highlights</u>

- Temperatures will likely remain below normal through June, then will likely trend closer to normal by mid to late summer
- The 2024 monsoon will likely start later than normal and be weaker than normal, leading to below normal precipitation and below normal lightning activity this summer
- Live fuel moistures, soil moistures, and heavier dead fuel moistures will continue to remain above average well into the summer due to the lingering effects of the wet winter, yielding below normal large fire activity through at least July



Weather Discussion

The past 3-month period, temperatures remained slightly below normal for most of the region while precipitation remained well above normal for most of the region (**Figures 1 and 2**). The only exception is the Central Valley, where temperatures remained slightly above normal (between 0°F and 1°F above normal). Some areas received over 200% of their normal late January – late April precipitation amounts (**Figure 2**).




Fig 3: Niño 3.4 Region SST Anomaly

The state of the equatorial Pacific is undergoing a transition from an El Niño state to an El Niño Southern Oscillation (ENSO) Neutral state as sea surface temperatures (SSTs) have shown signs of persistent cooling over the past 3 month period with SST anomalies across Niño 3.4 Region are now starting to remain between the 0°C and +0.5°C range. Spatially, the core of the warmest water remains in the central Pacific with cooler anomalies beginning to develop off the South American coast (**Figures 3+4**). This is a sign of the strengthening of the easterly trade winds which indicates a transition away from the El Niño state.

Fig 2: January 29th – April 27th Precipitation (% of Ave.)




Fig 4: Niño 1+2 Region SST Anomaly



Fuels Discussion





Fig 6: Los Padres NF Live Fuel Moistures from April 1st, 2024

Latest USDA Drought Monitor shows no areas in drought status across Southern California (**Figure 5**). There is only a small area of the eastern desert that is considered abnormally dry (D0), however this area is not in drought status. Live fuel continues to remain above average for most of the region (**Figure 6**). Seasonal live fuel maximums will likely be higher than average and occur later than average especially in mid and higher terrain. Larger dead fuel moisture for most of the region with the exception of the Eastern Sierra remains above normal while Energy Release Components (ERCs) remain below normal for most of the region with the exception of the Eastern Sierra (**Figures 5 and 6**).




Fig 7: 1000hr Dead Fuel Moisture by PSA Map

SOUTH OPS OUTLOOK

Climate models suggest a transition across the equatorial Pacific from the El Niño state to La Niña state over the summer. This results in a slight tilt in the odds towards a warmer and drier period. However, there is a lower than average confidence given summer is the time of year when ENSO is at its weakest combined with conditions either remaining in the ENSO Neutral category or a weak La Niña. Another reason the odds tilt slightly towards a warmer and drier summer is the cold SST anomalies in the Gulf of California. The cold anomalies in the Gulf of California will help promote atmospheric stability and lessen the chance for convection to develop over the Gulf of California and move over the Southwestern U.S.

For fuels, there is a high confidence dead and live fuel moisture remains above normal across the various mountain ranges, especially the Central and Southern Sierra through July. There is a moderate to high confidence the dead and live fuel moistures remain above normal for the coastal locations through July. There is more forecast uncertainty for August given the latest temperature and precipitation forecast. There is likely to be a larger fuel load this year given the excess precipitation in the late winter and spring months combined with the lack of significant fires during the previous season. Due to this, the odds tilt slightly towards near normal large fire potential rather than below normal for August.




Fig 8: Sea Surface Temperature Anomaly, April 27th, 2024




Fig 9: NMME June - August 2024 3-month Precipitation Anomaly Forecast



RECOMMENDATION:

Staff recommends the Board of Directors approve the budget amendment for Fiscal Year (FY) 2023/2024, as proposed.

BACKGROUND:

The practice of routinely reviewing actual, anticipated, or unforeseen expenditures associated with an adopted budget provides the agency the opportunity to make periodic adjustments to ensure the adopted budget stays centered and transparent. Based on the unanticipated costs/savings associated with the current adopted FY2023/2024 budget commitments, staff propose the following budget amendment.

CURRENT:

The RSF Professional Firefighters Association and the RSF Employee Association both negotiated a new 3-year memorandum of understanding (MOU) which became effective on January 1, 2024, and extends to December 31, 2026. The first year for both MOUs reflects a 19% wage increase. The original FY2023/2024 budget was presented with a 3% salary increase prior to any labor negotiations started. To ensure this substantial increase and impact is reflected in our annual budget, we recommend the following changes to adjust for salary expenditure. This report identifies the proposed budget adjustments.

The FY2023/2024 salary, wages, and overtime were increased. The amount budgeted for the districts monthly and normal UAL employer paid contribution to CALPERS were correctly adjusted. There were slight adjustments required for payroll taxes. The FY2023/2024 budget line item for the PERS employer paid contribution reflected an amount that was higher than calculated, and therefore reduced.

STAFF REPORT 09-21

The two items resulted in an overall \$289,690 fiscal impact on the adopted FY2023/2024. This impact is approximately a 2% adjustment overall.

RECOMMENDATION:

Staff recommends the Board approve the itemized fees required for a total cost of \$17,064.00 to complete the forced abatement process and further authorize administrative staff to invoice the property owner (parcel number) listed below of the approved fees.

CURRENT SITUATION:

The fire district has sent a report and notification of today's hearing to the last known owner of the parcel as listed in the County of San Diego Tax Assessor Office a minimum of (3) three days prior to this regularly scheduled Board of Directors meeting (See Exhibit A)

Upon Board approval today, administrative staff will mail (certified) a district cover letter and invoice requesting payment within 30 days of the invoice date for the itemized fees to abate the parcel number listed below.

Should the property owner fail to provide payment to the fire district within 30 days of the invoice date, the fire district will publicly post a minimum of (3) three days prior to the regularly June Board of Directors meeting for Weed Abatement Special Assessment approval.

Upon Board approval the list will be sent to the County of San Diego Tax Assessor prior to their August deadline. The County of San Diego will reimburse the fire district for all charges, including administrative fees, and will include the fees on the property owner's next property tax bills.

BACKGROUND:

The fire district's prevention bureau is responsible for mailing the annual district's notification which educates and encourages property owners to comply pursuant to the current **Rancho Santa Fe Fire Protection District's Ordinance No. 2022-02**. Compliance with the ordinance is key to the safety of the community that is located within a very high fire hazard severity zone. The fire district typically will find a large percentage of property owners willingly comply within the 15-calendar day timeline allowed.

However, for the property owner(s) who is not compliant pursuant to the current Rancho Santa Fe Fire Protection District's Ordinance, the following procedures is implemented:

- 1. The fire district will conduct a weed abatement inspection and will provide a "First Notice" (1st Class Mail) to notify the property owner(s) to correct any issues not in compliance with the Rancho Santa Fe Fire Protection District's Ordinance within 15-calendar days of the first notice date.
- 2. Should the property owner continue to fail with the specific timeline of the first notice, the fire district will serve a "Final Notice" (Certified Mail) to notify the property owner(s) to correct any issues not in compliance with the Rancho Santa Fe Fire Protection District's Ordinance within 10-calendar days of the final notice date.
- 3. Should the property owner continue to fail with the specific timeline on the final notice, the fire district will conspicuously post a sign on the property a "Notice to Abate Hazard" to notify the property owner(s) to correct any issues not in compliance with the Rancho Santa Fe Fire Protection District's Ordinance within 10-calendar days of the date posted on the sign to avoid a forced abatement by the district.
- 4. Should the property owner continue to fail with the specific timeline on the posted sign "Notice to Abate Hazard", the fire district will request a bid from the sole source private contractor to abate the parcel to be compliant with the Rancho Santa Fe Fire Protection District's Ordinance. The fire district can approve and authorize the contractor to abate the parcel.
- 5. Should the property owner refuse access to the property for the fire district and contractor to force abate the parcel, the fire district can obtain an "Abatement Warrant and Order Authorizing Entry onto The Property to Abate the Public Nuisance".
- 6. Once the contractor has completed the authorized forced weed abatement work and the fire district has accepted the final work. The fire district will pay the contractor for the approved and completed work. The staff will request Board approval for all the associated costs and fees required to abate the parcel. The Board approval will also authorize staff to invoice the property owner.

The fire district attempts to work with the property owner prior to any forced abatement. The district maintains a sole source contract with R.E Badger & Son Inc. to bring specifically identified hazardous parcels into compliance pursuant to the Rancho Santa Fe Fire Protection District's Ordinance.

SUBJECT: FY2024/2025 CALPERS ADDITIONAL DISCRETIONARY PAYMENT

DATE: MAY 15, 2024

RECOMMENDATION:

The staff request an open discussion and to be given direction by the Board of Directors regarding a proposed CalPERS Additional Discretionary Payment (ADP) for Fiscal Year (FY) 2024/2025 budget.

BACKGROUND:

The fire district has taken an aggressive approach in trying to reduce the CalPERS unfunded accrued liability (UAL) by providing an ADP each fiscal year since 2015, except FY2023/2024.

CURRENT:

FY2023/2024 approved ADP amount is \$697,000.00. However, the district missed the deadline of April 15, 2024, that could have allowed the budgeted \$697,000 ADP to potentially reduce our required contributions for FY2024/2025.

Staff discussed with the assigned CalPERS actuary on May 3, 2024, the options moving forward. The district can make an ADP in FY2024/2025 and reduce our required contributions for FY2025/2026. The deadline to have that included in the annual valuation will be by mid-April 2025.

SUMMARY:

Staff request an open discussion with the Board of Directors to evaluate the options and formulate a financially sustainable plan for the district to move forward to manage the unfunded accrued liability.

DATE: MAY 15, 2024

RECOMMENDATION

Staff recommends a change in vendor for our Deferred Compensation/457 plan, the district's deferred tax investment program available for active and retired employees. Staff recommends changing from Voya & Nationwide to Empower.

BACKGROUND

Prior to having two options for the 457 plans, the district contracted with ING (formerly Aetna) and now VOYA. Throughout the years the original account representatives have been providing financial consultation to all employees and retirees. In 2014, the district added Nationwide as an option for employees that offered different fund choices and lower fees. Additionally, the district is required to monitor contribution limits for the employees and to adhere to fiduciary obligations by regularly reviewing recordkeepers and the underlying investments offered in the plan.

CURRENT SITUATION

We have experienced a reduction in customer service over the past few years when the account representatives changed at both Voya and Nationwide. Julia Rhea and Dominic Randazzo (now with Lincoln Financial), the former account representatives with Voya, were requested to look at different options in the 457 market. They collected the data for all the current assets in the 457 plans and requested proposals from several different providers. They researched plans and the associated fees and arranged presentations from Lincoln and Empower. Also note that there are limited providers offering deferred compensation/457 plans.

A subcommittee was formed with members from all ranks, including the retirees, to discuss the pros and cons of switching 457 providers. Nationwide offers a variety of mutual funds and a fixed account. Voya also offers a variety of mutual funds as well as fixed accounts. Voya has a 4% fixed account option for those employees 'grandfathered' into this benefit. Currently there are (17) active employees (out of 67 total Active employees) that are grandfathered into this account and only (7) of those have greater than a \$10k balance. This 4% account was an attractive option for many years in the past, but with current interest rates this benefit may not be as relevant as in

years past and is not available to most employees. Most of the assets in the 457 fixed account with Voya are held by the retirees. As a retiree they have the option to roll funds out of any 457 plan (based on separation of service) into potentially higher interest IRA yielding accounts that are currently available on the market.

After several committee meetings, the decision was narrowed down to recommend Empower as a fiscally prudent option with reduced fees and lower fund expenses. In addition, their online platform is much easier to use and dynamic in its ability to combine a user's entire portfolio from all financial investments. Julia Rhea and Dominic Randazzo would be the advisors for this plan and would advocate for maintaining low fees, review underlying investments, and evaluate recordkeepers moving forward. Additionally, the committee reached out to other fire agencies for feedback on Empower and found that agencies were happy with the funds and the service.

The chart below shows the reduction in plan fees and fund expenses in consolidating plan assets and choosing Empower as our 457 recordkeeper. In addition, the Advisor fee is also included in the graph below.

With a higher level of customer service, lower overall fees, and a user-friendly platform, this change would benefit all employees and encourage participation and education among newer employees. The committee understands that the 4% fixed account available with Voya would no longer be an option for those that were 'grandfathered' in. This plan is only grandfathered in for a minority of Active Employees and Retired employees have other options in the market. Dominic and Julia would be the point of contact and "hands on" with all employees including retirees in the transition of this plan.

For additional information, our current HRSA (Health Retirement Savings Account) was voted by the VEBA Trustees to move away from Voya and they have chosen to transition to BPAS as a new provider for improved customer service and reduced fees, as well as ease of use by retirees for reimbursements (moving away from the current provider TASC). Julia and Dominic with Lincoln will be the direct advisors for this plan as well.

The subcommittee has presented the findings noted in this staff report to the Fire Chief, who has fiscal responsibility over the 457 plan and making recommendations to the Board.

Price Factor and Population Information

Appropriations Limit

California Revenue and Taxation Code section 2227 requires the Department of Finance to transmit an estimate of the percentage change in population to local governments. Each local jurisdiction must use their percentage change in population factor for January 1, 2024, in conjunction with a change in the cost of living, or price factor, to calculate their appropriations limit for fiscal year 2024-25. Attachment A provides the change in California's per capita personal income and an example for utilizing the factors to calculate the 2024-25 appropriations limit. Attachment B provides the city and unincorporated county population percentage change. Attachment C provides the population percentage change for counties and their summed incorporated areas. The population percentage change data excludes federal and state institutionalized populations and military populations.

Population Percent Change for Special Districts

Some special districts must establish an annual appropriations limit. California Revenue and Taxation Code section 2228 provides additional information regarding the appropriations limit. Article XIII B, section 9(C) of the California Constitution exempts certain special districts from the appropriations limit calculation mandate. Special districts required by law to calculate their appropriations limit must present the calculation as part of their annual audit. Any questions special districts have on this requirement should be directed to their county, district legal counsel, or the law itself. No state agency reviews the local appropriations limits.

Population Certification

The population certification program applies only to cities and counties. California Revenue and Taxation Code section 11005.6 mandates Finance to automatically certify any population estimate that exceeds the current certified population with the State Controller's Office. Finance will certify the higher estimate to the State Controller by June 1, 2024. Please note: The prior year's city population estimates may be revised. The per capita personal income change is based on historical data.

Pursuant to Government Code §7901, special districts may annually choose one of the following by a recorded vote of the governing body:

1. Cost of Living:

- a. the change in California per capita personal income; or
- b. the percentage change in the jurisdiction's assessed valuation, which is attributable to nonresidential new construction.

2. Population:

- a. the change in population within the county.
- b. the change in population within the unincorporated area of the county.
- the use of specific formula calculations or estimates, permitted for mixed incorporated/unincorporated areas of special districts and/or special districts serving more than one county: or

Each year special districts should perform necessary calculations to determine if year-end proceeds of taxes subject to the limit have exceeded the limit. Preliminary calculations have been made for all revenue received to determine whether this district complies with the appropriations limits established for the current fiscal year. Preliminary calculations show that the district will comply with the appropriation limit.

The following recommendation is submitted for your consideration and/or action:

- 1. To select the change in California per capital personal income (3.62%) for the Cost-of-Living Factor and the change in population within San Diego County average (0.17%). A copy of the State of California Department of Finance Price & Population Data for Local Jurisdictions is attached. The District population provided by SANDAG is not available at this time.
- 2. The Board may choose to submit population documentation to the State Department of Finance Demographic Research Unit for certification by June 1, 2024. Note: there may be a charge by the State for this option. If this option is selected, the District can modify the Gann Limit after supporting documentation is received from the Department of Finance.

WHEREAS, pursuant to Section 53978 of the Government Code, the Board has determined that a special tax for providing structural fire protection by Rancho Santa Fe Fire Protection District serving the Elfin Forest/Harmony Grove areas shall appear as separate items on the tax bill and shall be collected at the same time and in the same manner as ordinary County ad valorem property taxes are collected; and

WHEREAS, the amount of charges for each parcel for fiscal year 2024/2025 have been computed in conformity with the procedure set forth in, and charges described by applicable ordinances, resolution, and agreement of the fire protection district.

THEREFORE, BE IT RESOLVED and is hereby determined and ordered as follows:

- 1. That every charge set forth in said report is adopted.
- 2. That said reports are hereby confirmed.
- 3. That said reports as confirmed by this board be filed with the Auditor & Controller of the County of San Diego.
- 4. That said assessment shall appear as a separate item on tax bills entitled RSF Elfin Forest/Harmony Grove Fire Protection Assessment
- 5. The cost for fiscal year 2024/2025 shall be \$200.87 per benefit unit, a 5.11% increase.
- 6. This assessment applies to all applicable parcels in the following tax rate areas:
